  - d) The customers User ("user" "you" "your)
- 1.2 My Dietitian Pty Ltd reserves the right to review and change any of the Terms by updating this page at its sole discretion. When My Dietitian Pty Ltd updates the terms, it will use reasonable endeavours to provide you with notice of updates of the Terms. Any changes to the Terms take immediate effect from the date of their publication.

## 2. Acceptance of the Terms
